

BYLAW NO. 473-97

OF THE TOWN OF CORONATION

IN THE PROVINCE OF ALBERTA

Being a Bylaw of the Town of Coronation, in the Province of Alberta, to prohibit the use of weapons within the corporate limits of the Town of Coronation and on lands under the direct control of the Town of Coronation situated outside the Town's corporate limits.

WHEREAS, by virtue of the power conferred upon it by Section 7 of the Municipal Government Act, Statutes of Alberta, Chapter M-16.1, the Council of the Town of Coronation in the Province of Alberta, duly assembled, enacts as follows:

Section 1.0 Short Title

- 1.1 This Bylaw shall be known and may be cited as the "Weapons Control Bylaw" of the Town of Coronation.

Section 2.0 Definitions

In this Bylaw, the following terms shall have the following meaning:

- 2.1 "Council means the Council of the Town of Coronation in the Province of Alberta
- 2.2 "Weapon" means any barreled firearm from which any shot, bullet or other projectile can be discharged and that is capable of causing bodily injury or death to a person and includes any frame or receiver of such a barreled weapon and anything that can be adapted for use as a firearm and includes an airgun having a velocity exceeding five hundred feet per second (500 fps) and includes any cross bow, bow or any other device that is designed to discharge a projectile such as an arrow or bolt
- 2.3 "Officer" means a police officer or a fish and wildlife officer or a designated individual appointed by the Town.
- 2.4 "Town" means the Town of Coronation

Section 3.0 Prohibitions

- 3.1 No person shall discharge a weapon within the corporate limits of the Town of Coronation or on lands under the direct control of the Town such as the Coronation cemetery, Coronation municipal airport, Coronation municipal campground and Coronation landfill

Section 4.0 Exceptions

- 4.1 A weapon may be discharged by an officer should he/she be required to do so in the course of conducting his duty

Section 5.0 Penalties

- 5.1 A person who contravenes a provision of this Bylaw by doing something he/she is prohibited to do is guilty of an offence and is liable upon summary conviction of a fine as set out in schedule "A"

6.1 This Bylaw shall come into force and effect on the date of the final reading thereof


READ A FIRST TIME this 21st day of October, 1997
